ENCORE BUS PASS CHECKLIST 2021/2022

- **APPLICATION** – MUST BE COMPLETED AND SIGNED BY BOTH PARENT/GUARDIAN AND STUDENT(S).
 - INCORRECT OR INCOMPLETE APPLICATIONS CANNOT BE PROCESSED.
- **SIGNED BUS RULES** – SIGNED BY BOTH PARENT/GUARDIAN AND STUDENT(S).

After a bus pass is issued the student must keep their ID/Bus Pass on them at all times to ride the bus. Please locate and review the student handbook for rules on ID cards. If an ID/Bus Pass is forgotten the student(s) will be subject to a bus citation by the bus driver. If a student does not have an application on file, they are **not eligible to ride the bus for any reason.**

BUS RIDERS RULES

1. STUDENTS MUST SECURE THEIR BUS PASS/ID **EACH SEMESTER** TO CONTINUE RESERVING THEIR SEAT.
2. STUDENTS WHO HAVE FORGOTTEN THEIR ID/BUS PASS MUST REPLACE IT AT A \$5.00 CHARGE TO THE STUDENT.
3. STUDENTS MUST RIDE ON ONLY THE **DESIGNATED BUS ROUTE TO THE DESIGNATED STOP.**
4. STUDENTS SHOULD ARRIVE AT THE DESIGNATED BUS STOP FIVE (5) MINUTES PRIOR TO PICK UP TIME.
5. **NO FOUL/OFFENSIVE, OR INAPPROPRIATE LANGUAGE PERMITTED.**
6. **NO DRINKING, EATING, OR CHEWING GUM ON THE BUS.**
7. NO WEAPONS OR DANGEROUS OBJECTS ALLOWED ON THE BUS INCLUDING PERFUME/COLOGNES, ANY SCENTED SPRAY BOTTLES OR SPRAY CANS OF ANY KIND.
8. STUDENTS WILL NOT THROW ANY OBJECTS INSIDE OR OUTSIDE OF THE WINDOWS OF THE BUS **NO LITTERING.**
9. STUDENTS WILL KEEP HANDS, HEADS AND ANY OTHER BODY PARTS INSIDE THE BUS AND TO YOURSELF.
10. **NO STANDING OR SWITCHING SEATS WHILE THE BUS IS IN MOTION. NO SITTING IN THE ISLE.**
11. NO SMOKING ON THE BUS OR NEAR DESIGNATED BUS STOPS.
12. STUDENTS WILL NOT VANDALIZE ANY PART OF THE BUS OR BUS STOP.(WRITING, CUTTING, ETC.)
13. STUDENTS WILL NOT FIGHT/PLAY FIGHTING ON THE BUS OR AT THE BUS STOP.
14. STUDENTS WILL NOT HARASS ANY STUDENT VERBALLY OR PHYSICALLY.
15. **STUDENTS WILL NOT TAKE PICTURES/VIDEOS ON THE BUS WITH A CELL PHONE, TABLET, CAMERA OR ANY MEDIA DEVICE.**
16. STUDENT WILL WEAR SEATBELTS “WHENEVER SEATBELTS ARE AVAILABLE” (CALIFORNIA STATE LAW)”.
17. AUDIO AND VISUAL EQUIPMENT CAN BE USED BY THE STUDENT SERVICES DEPARTMENT ONLY.
18. **PARENTS MUST FOLLOW ALL APPLICABLE TRAFFIC LAWS – INCLUDING NEVER STOPPING OR CUTTING OFF A BUS’ PATH IN MOTION WHEN PICKING UP OR DROPPING OFF STUDENTS. A PARENT’S DRIVING ACTIONS CAN ALSO JEOPARDIZE BUS RIDING PRIVILEGES FOR ALL STUDENT IN THEIR CAR.**
19. ALL BUS RIDING PRIVILEGES WILL BE SUSPENDED IF A PARENT IS CITED BY A CHP OR SHERIFF’S DEPARTMENT.
20. IF A STUDENT IS SUSPENDED FOR ANY REASON ALL BUS RIDING PRIVILEGES WILL BE REVOKED.

IF THE BUS RIDER HAS VIOLATED ANY ONE OF THE ABOVE RULES, HE/SHE MAY BE ASSIGNED A PERMANENT SEAT OR PRIVILEGES MAY IMMEDIATELY BE SUSPEND OR REVOKE.
